PROTECTION OF PERSONAL INFORMATION POLICY

Personal information:

Personal information is collected only when an individual knowingly and voluntarily submits information. Personal Information may be required to provide an individual with further services or to answer any requests or enquiries relating to this service.

It is Fortem Financial Services' intention that this policy will protect an individual's personal information from being prejudiced in any way and this policy is consistent with the privacy laws applicable in South Africa.

Fortem Financial Services collects, stores and uses the personal information provided by an individual, in order to provide an estimated insurance quotation.

Use of information:

Why Fortem Financial Services needs to collect personal or other information:

- For underwriting purposes
- Assessing and processing claims
- Conducting credit reference searches or verification
- Confirming and verifying an individual's identity
- For credit assessment and credit management
- For purposes of claims history
- For the detection and prevention of fraud, crime, money laundering or other malpractice
- Conducting market or customer satisfaction research
- For audit and record keeping purposes
- In connection with legal proceedings

- Inform an individual of services

Security:

Fortem Financial Services strives to ensure the security, integrity and privacy of personal information submitted. Fortem Financial Services will review and update its security measures in accordance with future legislation and technological advances. Unfortunately, no data transmission over the Internet can be guaranteed to be totally secure, however, Fortem Financial Services will endeavour to take all reasonable steps to protect the personal information, which an individual submits to Fortem Financial Services or to Fortem Financial Services online products and services. Fortem Financial Services will at all times set the highest standards to ensure the integrity of their systems.

Fortem Financial Services may engage with other organizations to provide support services. Third Parties are obliged to respect the confidentiality of any personal information held by Fortem Financial Services. A Service Level Agreement is in place with all Third parties to ensure adherence to all Privacy Policies.

Fortem Financial Services' employees are obliged to respect the confidentiality of any personal information. All employees are required to sign an employment contract, which includes a confidentiality clause.

Fortem Financial Services will not reveal any personal information to anyone unless:

- It is compelled to comply with legal and regulatory requirements or when the law otherwise allows it
- It is in the public interest
- Fortem Financial Services needs to do so to protect their rights

Fortem Financial Services endeavours to take all reasonable steps to keep secure any information, which they hold about an individual, and to keep this information accurate and up to date. If at any time, an individual discovers that information gathered about them is incorrect, they may contact Fortem Financial Services to have the information corrected.

Fortem Financial Services recognizes the importance of protecting the privacy of information collected about individuals, in particular information that is capable of identifying an individual ("personal information").

Conditions for the lawful processing of personal information:

According to the POPI Act there are eight conditions that must be complied with to ensure that the processing of personal information is lawful. These conditions include:

1. Accountability:

- The responsible party must ensure that the conditions set out in Chapter 3 of the POPIA and all the measures that give effect to such conditions, are complied with at the time of determining the purpose and the means of the processing.

2. Processing Limitation:

- Personal information may only be processed in a fair and lawful manner. It covers minimality, consent, justification and objection and collection of data directly from a data subject

Personal information may only be processed if:

- The data subject or a competent person, where the data subject is a child, consents to the processing;
- Processing is necessary to carry out actions for the conclusion or performance of a contract to which the data subject is party;
- Processing complies with an obligation imposed by law on the responsible party;
- Processing protects a legitimate interest of the data subject;
- Processing is necessary for the proper performance of a public law duty by a public body; or
- Processing is necessary for pursuing the legitimate interests of the responsible party or of a third party to whom the information is supplied.
- Fortem Financial Services will also ensure that any personal information that is processed by it was obtained directly from the data subject.

3. Purpose Specific:

- Fortem Financial Services will process personal information only for specific, explicitly defined, and legitimate reasons. Fortem Financial Services will inform data subjects of these reasons prior to collecting or recording the data subject's personal information.

4. Further Processing Limitation:

- Personal information will not be processed for a secondary purpose unless that processing is compatible with the original purpose.
- Therefore, if Fortem Financial Services wishes to process existing personal information for a purpose other than the purpose for which it was originally collected, Fortem Financial Services will first obtain additional consent from the data subject.

5. Information Quality:

- Fortem Financial Services will take reasonable steps to ensure that all personal information collected is complete, accurate and not misleading in any way.
- Where personal information is collected or received from third parties, Fortem Financial Services will take reasonable steps to confirm that the information is correct by verifying the accuracy of the information directly with the data subject or by way of independent sources.

6. Openness:

- Fortem Financial Services will take reasonable steps to inform all data subjects whose information is being collected of:
 - The information being collected and where the information is not collected from the data subject, the source from which it is collected;
 - The name and address of the responsible party;
 - The purpose for which the information is being collected;
 - Whether or not the supply of the information by that data subject is voluntary or mandatory;
 - The consequences of failure to provide the information;
 - Any particular law authorizing or requiring the collection of the information;
 - The fact that, where applicable, the responsible party intends to transfer the information to a third country or international organization and the level of protection afforded to the information by that third country or international organization.

7. Security Safeguards:

- The responsible party must secure the integrity and confidentiality of personal information in its possession or under its control by taking appropriate, reasonable technical and organizational measures to prevent loss of, damage to or unauthorized destruction of personal information; and unlawful access to or processing of personal information.
- To achieve the abovementioned results, the responsible party must take reasonable measures to:
- Identify all reasonably foreseeable internal and external risks to personal information in its possession or under its control;
- Establish and maintain appropriate safeguards against the risks identified;
- Regularly verify that the safeguards are effectively implemented; and
- Ensure that the safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards.

8. Data Subject Participation:

- A data subject may request whether their personal information is held, as well as the correction or deletion of his or her personal information held by Fortem Financial Services. Fortem Financial Services will take all reasonable steps to confirm your identity before providing details of your personal information.
